COVID-19 INFECTION PREVENTION NOTICE
CUSTOMERS AND TOURISTS

A GREEN PASS OR EQUIVALENT DOCUMENT IS REQUIRED IN ORDER TO ACCESS THE WINERY.

Close contact with someone testing positive for SARS-CoV-2, as defined in Ministry of Health Circulars, **must also be considered to be close contact for a vaccinated person**, so even in this latter case **all the provisions laid down by the Health Authorities must be complied with.**

Those who have been vaccinated once or twice **MUST CONTINUE TO COMPLY WITH ALL THE COVID PREVENTION MEASURES**, including **social distancing**, **the use of a face mask** (and the PPE provided) and **hand hygiene**, as it is not yet known whether the vaccine is also effective in preventing infection and/or transmission to others.

1) NO ACCESS TO OR REMAINING ON COMPANY PREMISES, GIVING IMMEDIATE NOTICE in the event of:

- TEMPERATURE ABOVE 37.5°
- flu-like symptoms (e.g. dry cough, sore throat, diarrhoea, nasal congestion, loss/reduction in sense of smell and taste)
- Contacts with anyone who, in the last 14 days, has tested positive for COVID-19 or come from somewhere indicated by the WHO as being in a risk area, which gives rise to an absolute obligation to stay at home (quarantine or self-isolation)

2) OBLIGATION TO COMPLY WITH ALL COMPANY REGULATIONS, and in particular:

- KEEP YOUR SURGICAL FACE MASK WITH YOU AT ALL TIMES AND USE IT CORRECTLY ON EVERY OCCASION, **BOTH IN CLOSED SPACES AND IN THE OPEN, REMOVING IT ONLY WHILE TASTING.**
- cleansing of hands using the alcohol-based gels provided at the entrance, and correct hygiene
- no access to company premises without authorization
- observance of any further notices/procedures provided on arrival at the company
- reporting without delay of the existence, also following entry, of any conditions of risk (flu-like symptoms, high temperature, arrival from areas of risk or contact during the previous 14 days with anyone who has tested positive for the virus, etc.) that the family doctor and the health authorities are required by official regulation to be informed of and that necessitate staying at home
